SECTION C - Description/Specifications

C.1 SCOPE OF WORK - CONSTRUCTION ACNC-0001-A

The Contractor shall furnish all supervision, labor, materials, and equipment necessary to construction of a primitive campground featuring 12 (twelve) campsites, pavilions, picnic tables, cowboy caldrons, and a walking path made of pea gravel. The campground shall provide a rustic and natural camping experience without modern amenities such as electricity or running water aboard MCAS Cherry Point, NC.

- C.2 BACKGROUND MARINE CORPS NONAPPROPRIATED FUND INSTRUMENTALITIES ACNC0002
- 1. The Business and Support Services Division (MR), Headquarters, United States Marine Corps (HQMC), Quantico, Virginia, under the staff cognizance of the Deputy Commandant for Manpower and Reserve Affairs, is responsible for providing policy, plans, resources, and support to Marine Corps Community Services (MCCS) and Marine Corps Hospitality Services (MCHS) activities. MCCS generates over \$1 billion in sales per year from a wide variety of business operations. Earnings from major MCCS revenue generators are used to help fund non-revenue generating MCCS programs. Additional information on MCCS is available at www.usmc-mccs.org.
- 1.1. MCCS provides commanders with an integrated organization for the development and delivery of Quality of Life (QOL) programs and services. MCCS operates family, fitness, and recreation; exchange and business services; and other QOL programs and services for Marines and their families. MCCS activities are operated on Marine Corps Installations on the East and West Coasts of the United States; Hawaii; Iwakuni, Japan; and Okinawa, Japan. The administration, management, and operation of local MCCS activities are the responsibility of each Installation Commander.
- 1.2. MCHS, the Official Lodging Program for the Marine Corps, is under the operational control of HQMC MR and provides a professionally managed, business-based lodging program that provides affordable lodging and hospitality services for a mobile military community. The Official Lodging Program consists of sister brands: "Inns of the Corps" and "Marine Lodge." Inns of the Corps are temporary lodging facilities, and the Marine Lodge are temporary duty billeting facilities. Like any high performing hospitality entity, garnering guest satisfaction, preference and loyalty through engaging staff and a unique and warm physical environment are of utmost importance.
- 2. MCCS, including MR when dba MCCS, and MCHS activities are Nonappropriated Fund Instrumentalities (hereafter, NAFIs) of the U.S. Government and are therefore subject to directives issued by the Department of Defense, the Secretary of the Navy, and the Commandant of the Marine Corps. NAFIs execute contracts using nonappropriated funds (NAF). NAF contracts are not subject to the Federal Acquisition Regulation

(FAR), Defense Federal Acquisition Regulation Supplement (DFAR), or DoD Component Supplements, however, there may be references to the FAR included in this contract solely for the administrative convenience of the NAFI. Unless otherwise provided, (1) the referenced FAR clause shall have the same force and effect as if it were in full text, and (2) any reference to the "Government" in the FAR clauses shall be construed to mean the NAFI unless otherwise noted. This contract may incorporate one or more clauses or laws by reference, with the same force and effect as if they were given in full text.

C.3 NAF CONSTRUCTION PROGRAM - BACKGROUND ACNC-0003-E

- 1. The Contractor shall perform work under this contract for Construction and/or Design-Build (D/B) services in support the NAF Construction Program and other NAF projects within [GEOGRAPHIC REGION] .
- 2. The NAF Construction Program and other NAF projects include, but are not limited to, construction of new or repair and renovation of existing Marine Marts/Exchanges (MCX), Lodging Facilities (MCHS), Car Washes, Golf Courses, Golf Clubhouses/Maintenance Facilities, Officer and Consolidated/Enlisted Clubs, Youth Centers, Outdoor and Indoor Recreation Centers, Bowling Centers, Auto Skills Centers, Community Activity Centers, RV Parks/Travel Camps, Cottages/Cabins, Sports Complexes/Fields/Courts, Theaters, Marinas, Swimming Pools (indoor and outdoor), Aquatic Centers and other MCCS activities. Projects may include multipurpose/multifunctional facilities or complexes for multiple program requirements.

C.4 STATEMENT OF WORK ACNC-0004

Contractor shall:

1. Site Preparation

- a. Conduct a detailed survey of the site to mark the boundaries of the campground, individual campsites, and the walking path.
- b. Clear the area of any debris, vegetation, and obstacles.
- c. Grade the land to ensure proper drainage and a level surface for campsites and pathways.
- d. Spoils to remain on the Marine Corps Air Station Cherry Point at a designated location provided by the COR.
- e. Implement measures such as silt fences and erosion control blankets to prevent soil erosion during and after construction.

2. <u>Campsite Construction</u>

- a. Designate and mark twelve (12) individual campsites, ensuring each site is spaced adequately to provide privacy and minimize environmental impact.
- b. Design shall be submitted for approval prior to any construction. See figure 1.0 below for planned locations of each site.
- c. Level the ground at each campsite and cover with a layer of compacted soil or gravel to provide a stable base.

d. Campsite Pads

- (1) Each pad should be 12'x14' per campsite.
- (2) Pad shall be made with crushed ABC over a ground stabilization grid and geotextile fabric base to prevent weed growth and surrounded with 6"x6"x14' pressure treated timbers.
- (3) Each campsite shall include an adjacently attached $12' \times 14'$ (feet) wide and 4'' (inches) thick pad made of Glass Fiber Reinforced Concrete (GFRC) to provide a fire-resistant surface for picnic table and cowboy caldron installation.

e. Picnic Tables and Urban Cowboy Caldrons

- (1) <u>Picnic tables</u>. Provide and install one (1) each durable, weather-resistant treated lumber picnic table at each campsite and six (6) each under the Pavilion, painted brown using a wood preventative solid color stain for a more rustic appearance. (Color TBD)
 - (2) Anchor all picnic tables to prevent movement.
- (3) <u>Urban Cowboy Caldrons (30"Dx70"Hx72"W)</u>. Provide and install thirteen (13) each Urban Cowboy Caldron's (cowboycaldron.com). (Note: Twelve (12) Urban Cowboy Caldron's (large cooking pots) shall be installed at each site communal area and one (1) Urban Cowboy Caldron shall be installed at the pavilion area.)
- (4) Ensure the Urban Cowboy Caldron's are installed on stable, fire-resistant surfaces.

f. Walking Paths Construction

- (1) Construct "Walking Paths" that connect to all the twelve (12) campsites and communal area.
- (2) Ensure the path is accessible and follows the natural contours of the land.
 - (3) Excavate the path area to a depth of 4" (inches).
- (4) Lay a 3.2oz (ounce) geotextile fabric to prevent weed growth and install Agtec Geocell Ground Grid Paver, SKU AGT-GS75 ground stabilization grid per manufacturers specifications. Then fill with pea gravel.
- (5) Compact the pea gravel to create a stable walking surface.
- (6) Path shall be 6^\prime wide to each campsite and 6^\prime from campsite area through woods to road access.

g. Pavilion Construction

- (1) Provide and install one (1) $16' \times 20'$ outdoor pavilion (metal exposed structure) with standing seam metal gable roof in a forest green color on a 6'' (inch) concrete slab.
- (2) Metal structure shall be painted with Sherwin Williams weather resistant pant Seal Brown color. Low eave shall be min 10' (foot) off Roof shall be 4/12 pitch.
- (3) Provide and install an additional 16'x12' concrete slab attached to the pavilion to serve as a fire pit patio and install one (1) Urban Cowboy Caldron in the center of the patio area.
- (4) Provide and install 6 gravel base at pavilion slab location and compact.
- (5) Prime and paint two (2) coats of weather resistant finish paint on metal structure exposed below roof (Color: Sherwin Williams Seal Brown).
- (6) Concrete slab shall be 3000psi concrete with repair and anchor bolts as needed for column foundations with a 6" gravel base. Concrete shall be broom finished, saw cut slab as required.
- (7) Provide and install stone veneer (Color and style TBD) 4' (feet) high on each pillar to include sill, caps, and receptacle boxes as needed. (See Section J).

(8) Electric Service

a. Run electrical service to new pavilion with a 100amp subpanel.

- b. Provide conduit and wiring from the new panel at building to support new electrical devices.
- (9) Provide and install six (6) each LED light fixtures (four (4) in the Pavilion Area and two (2) under each rake) and controlled by a commercial spring wound in-wall timer switch, metal finish, 120-minute time cycle, SPST Intermatic FF120MC.
- (10) Provide and install one (1) Hunter Trak Outdoor 96" fan, item #76286. Ceiling fan shall be controlled by a commercial spring wound in-wall timer switch, metal finish, 120-minute time cycle, SPST intermatic FF120MC.
- $\hspace{1.5cm} \hbox{(11) Provide and install two (2) each GFCI } \\ \hbox{receptacles.}$

(12) Water

- a. Install/run a water line to the new pavilion from the existing RV Park Campground.
- b. Provide and install one (1) each frost free water fill station with all lines running through the slab. (lines should be no less than $\frac{1}{2}$ "). (ELKAY Outdoor Bottle Filler, tubular (pedestal style), Color: Evergreen, item #LK4400BFEVG. See Section J.)
- c. Provide and install six (6) each durable weather-resistant treated lumber picnic tables under pavilion, color: Stain (no paint), Brown, preventative solid color to give a rustic appearance.

h. Parking Lot Construction

- (1) Measure the area at the end of Monroe Drive to accommodate twelve (12) parking spaces.
- (2) Grade, level and provide crushed ABC gravel over a ground stabilization grid and geotextile fabric base to prevent weed growth.
- (3) Provide and install 8"x8"x10' pressure treated timbers on three (3) sides designating the parking area.

C.5 CONSTRUCTION REQUIREMENTS ACNC-0024-E

The Contractor shall be responsible for all work described herein. The Contractor's design and construction must meet the intent to provide a completed facility of commercial quality which shall operate efficiently, without unreasonable architectural or mechanical, electrical, or plumbing (MEP) failures or deficiencies throughout the expected lifespan of the facility.

- 1. All materials used must meet fire protection requirements for noncombustible construction and satisfy local, military, and governmental codes and industrial standards and regulations.
- 2. The Contractor shall be responsible for securing and roping off the site, including the lay-down area, if required.
- 3. Contractor shall obtain all utility location markings and permits as required.
- 4. The Contractor shall immediately notify the Contracting Officer's Representative (COR) and promptly repair/replace any damage to structures, elements, utilities, finishes, etc., occurring due to construction.
- 5. Upon completion, the Contractor shall fill in, grade, or reseed any ruts or bare spots created by the Contractor's machinery or vehicles.
- 6. All work shall conform to the current regulations of the Environmental Protection Agency (EPA), and the Occupational Safety and Health Administration (OSHA). The Contractor shall comply with all safety requirements for the work area to include, but not limited to, hard hat, protective eye wear, and reflective vest as well as other safety equipment as may be required by the Installation public works or safety office.
- 7. The Contractor shall ensure all its employees and representatives are in proper attire and conduct themselves in a professional manner at all times. If any of the Contractor's employees or representatives do not comply, they shall be barred from the construction site.

Survey Rate Identifiers

no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.
